



The judgment is dated 11th January 2019, this is noticeably over 6 years from the default date.

I very rarely check my credit report, so it was only when a job application required a credit check, that I looked and was horrified to see a CCJ on my report. I have also not received any notification that a CCJ had been made against me.

The judgment shows an old address of XXX. My electoral roll was fully up to date so my new address could easily have been identified by the claimant.
